Dear Prof. Samushia:

We the undersigned have served as outside evaluators of grant proposals submitted to the Shota Rustaveli National Science Foundation of Georgia. Many of us have participated in this process in previous years, including last year's competition, which was administered by the European Science Foundation (ESF).

Earlier this year, thirteen projects submitted in 2021, which we and our colleagues evaluated, were awarded funding by the Rustaveli Foundation. The recipients of these grants were, however, refused access to their research funds on purely procedural grounds by a newly-formed "directorate" of the Georgian National Museum (GNM) system. This directorate comprises the general director of the GNM, Prof. David Lortkipanidze, who supported funding the 13 projects, and four newly-appointed members — of which only one is a professional historical or social scientist — who voted against him. Although most of the grants were eventually allowed access to funding, in the face of protests by Georgian and foreign researchers, one remains blocked.

We also note with concern the dismissals and demotions of dozens of staff members at the Janashia Museum of Georgia and the Amiranashvili Museum of Fine Arts, and obstruction in the issuance of permits to archaeological expeditions.

The majority of the researchers who were dismissed from the GNM had been awarded grants from the Rustaveli Foundation. It is important to note that these scholars have been unable to carry out the research specified in the grant proposals, due to denial of access to Museum collections. Even though the dismissed scientists wrote an official letter to the GNM directorate requesting the right to enter the collections to continue their research, they still have not received a response. The Georgian National Museum is a public entity, and therefore, any Georgian citizen has the right to enter the GNM collections for the purposes of conducting scholarly research.

Our participation in the proposal-review process is motivated by our firm belief that Georgian research in the natural, social and historical sciences should be assessed according to the same standards as those obtaining in Europe, the Americas and elsewhere; and that decisions regarding the funding of projects and the employment of researchers should be based on the merits of the projects and individuals concerned, rather than their political loyalties or opinions on government policies.

In view of the above-mentioned events, among others that have occurred since the appointment of the new minister of culture last year, we will closely follow the fate of the grant proposals we will evaluate in the upcoming Rustaveli Foundation competition, and in general, the situation of our colleagues at the various institutions of the Georgian National Museum system.
